

ORDINANCE NO. 5

AN ORDINANCE CREATING BLACKHAWK VILLAGE AREA WATER DISTRICT IN THE TOWNSHIP OF SOUTH BEAVER, BEAVER COUNTY, PENNSYLVANIA, TO INCLUDE THOSE PROPERTIES BENEFITED AND ABUTTING WATER LINES TO BE LAID ON PORTIONS OF BLACKHAWK ROAD (PA. ROUTE 251), ALL OF ARROWHEAD DRIVE, ALL OF PINECREST DRIVE AND A PORTION OF LEGISLATIVE ROUTE 04003 IN SAID TOWNSHIP BY THE ESTABLISHMENT OF THE WATER LINE ON BLACKHAWK ROAD (PA. ROUTE 251) WEST FROM THE CHIPPEWA-SOUTH BEAVER TOWNSHIP LINE 3,674 FEET MORE OR LESS; 2,000 FEET ON ARROWHEAD DRIVE; 2,200 FEET ON PINECREST DRIVE AND LEGISLATIVE ROUTE 04003; AND 856 FEET WEST ON BLACKHAWK ROAD (PA. ROUTE 251) FROM WESTWARDLY INTERSECTION OF ARROWHEAD DRIVE AND BLACKHAWK ROAD TO THE POINT OF TERMINATION; SAID POINT OF TERMINATION BEING 550 FEET MORE OR LESS EAST OF THE INTERSECTION OF GEORGETOWN ROAD AND SAID BLACKHAWK ROAD (PA. ROUTE 251); SAID WATER DISTRICT IS CREATED FOR THE INSTALLATION OF WATER MAIN SERVICE, FIRE PROTECTION AND APPROPRIATE FIRE HYDRANTS AND THE NECESSARY INCLUSION AND ASSESSMENT OF ALL PROPERTIES ABUTTING THE SAME.

IT IS HEREBY ORDAINED AND ENACTED into law by the Board of Supervisors of South Beaver Township that the following Water District is hereby created in the said Township for the purpose of entering into contracts, laying water lines and appropriate fire hydrants and making assessments upon the property owners affected hereby pursuant to the Act of Pennsylvania General Assembly of May 1, 1933, P.L. 103, as amended by Act of July 10, 1947, P.L. 1481, otherwise known as the Second Class Township Code,

BLACKHAWK VILLAGE AREA WATER DISTRICT:

Beginning from the Chippewa-South Beaver Township line in a westwardly direction on Blackhawk Road (Pa. Route 251) 3,674 feet more or less to Arrowhead Drive;

2,000 feet on Arrowhead Drive; 2,200 feet on Pinecrest Drive and Legislative Route 04003; and 856 feet more or less West on Blackhawk Road (Pa. Route 251) to the point of termination, said point of termination being 550 feet more or less East of the intersection of Georgetown Road and said Blackhawk Road (Pa. Route 251) and the inclusion and assessment of all properties abutting the same.

The members of the Board of Supervisors of South Beaver Township are hereby authorized to do all acts necessary for the carrying out of this Ordinance, including making contracts and assessments therefore, in accordance with the laws of this Commonwealth, provided, however, that no contract shall provide more pipeline than is necessary for the entire frontage of the lots to be benefited in this Water District.

ENACTED AND ORDAINED into law this 9th day of March, 1963, to become effective upon the publication thereof and adoption as required by law.
