TOWNSHIP OF SOUTH BEAVER

ORDINANCE NO. 30

AN ORDINANCE OF THE TOWNSHIP OF SOUTH BEAVER, BEAVER COUNTY, PENNSYLVANIA,

DESIGNATING THE SUPERVISORS OF THE TOWNSHIP AS AN AUTHORIZED COMMISSION TO

EXERCISE ANY AND ALL REGULATORY PROVISIONS INCLUDED AND SET FORTH IN THE

VEHICLE CODE AND TO AUTHORIZE, EMPOWER AND CONFIRM THE SOUTH BEAVER TOWNSHIP

POLICE FORCE TO ENFORCE ALL SAID REGULATORY PROVISIONS.

BE IT ENACTED AND ORDAINED by the Supervisors of South Beaver Township,
Beaver County, Pennsylvania, and it is hereby enacted under the authority
of the Township Code and the Vehicle Code, the following:

- I. The Supervisors of the Township of South Beaver, Beaver County, Pennsylvania, are hereby designated to be and are empowered as an authorized Commission pursuant to Section 6109 (b)(2) of the Vehicle Code to exercise any and all action permitted by a local authority for the establishment of any regulatory provisions as to vehicular use within the Township as set forth and included in the Vehicle Code, including but not limited to those particular items enumerated under Section 6109(a) of the Vehicle Code, which subsection is here incorporated by reference as same now exists or as hereinafter amended.
- A. All action undertaken and authorized by the Commission shall be exercised by a majority of its members, and its action shall be confirmed in writing signed by the approving members thereof, which writing shall be included and approved into the Minutes of a general meeting of the Supervisors of the Township of South Beaver. Except in the event of an emergency situation, all formal action of said Commission shall be exercised at a public meeting of the Supervisors of the Township of South Beaver.
 - B. A copy of the said writing signed by the approving members of

the Commission, certified as a true and correct copy of the original by the Secretary of the Township of South Beaver, shall be due and proper proof and evidence of any official action of the Commission.

II. The Police Force of South Beaver Township, pursuant to any and all legislative authority, have been and are being hereby confirmed as having full and regulatory powers to enforce all provisions of the Vehicle Code, according to and as permitted by the terms and provisions of the said Vehicle Code and any and all related legislation, including but not limited to any regulatory measure set and/or established by the aforesaid Commission, and to prosecute according to law any violators thereof.

III. This Ordinance shall be effective five (5) days after enactment, and to the extent that any Ordinance now in effect shall be consistent herewith, same is incorporated herein by reference, and to the extent any said Ordinance now in effect is inconsistent herewith, the inconsistent provisions thereof are hereby repealed. Nothing herein is to be deemed to revoke any and all exercise of the police powers of the Township of South Beaver heretofore exercised. The provisions of this Ordinance shall be severable, and if any part hereof shall be held illegal, such decision shall not affect the validity of the remaining provisions.
