

Minutes of South Beaver Township Regular Meeting

November 9, 2010

The regular November meeting of the South Beaver Township Board of Supervisors held in the Municipal Building on State Route 168 was called to order at 7:10 P.M. by Chairman Matthew Balik. The Pledge of Allegiance followed.

Officials present: Matthew Balik, Robert Long, Daniel Rastatter, Carol Miller, David L. Gropp, Craig Baker

Others present: Andy Leech

Bob Long made a motion to approve the minutes of the last meeting. Dan Rastatter seconded the motion. Motion carried.

Dan Rastatter made a motion to approve the Treasurer's Report and pay the following bills: General Fund, Check #9039 - #9068, Total \$17,262.33; Payroll Fund, Check #6821 - #6836, Total \$12,387.33; State Fund, Check #1884, Total \$1,997.07. Bob Long seconded the motion. Motion carried.

Carol read the Police Report and it will be filed.

There was no Road Report.

Carol read the Fire Report and it will be filed.

No action was taken on the comcast renewal contract.

Solicitor David Gropp made a couple of changes to the garbage contract. He included leaf collection in the residential district. It would be handled separate from the garbage contract. If someone wanted to use this service, they would have to buy stickers and pay an additional fee. The supervisors are to review the revised contract and let the secretary know if any other changes need to be made. It will then be advertised in the newspaper. Dan Rastatter suggested information be posted on the township web site to inform township residents.

Bob Long made a motion to approve the Brenda Raisley reversed subdivision plan located on Georgetown Road. Two parcels will be combined into one parcel. Matt Balik seconded the motion. Motion carried.

Matt Balik made a motion to participate in the 2010 joint ad for the MS-4 requirement of the Stormwater Management Act. The Beaver County Planning Commission prepares the notice and publishes it in the newspaper. A prorated cost to all participating municipalities is charged by the county. Bob Long seconded the motion. Motion carried.

A letter was received from the Beaver County Regional Council of Governments requesting information on the appointed delegate and alternate delegate to COG. Bob Long will continue to be the designated delegate, Matt Balik and Dan Rastatter the alternates for 2011.

A letter was received from the Beaver County Recreation & Tourism Department inviting the township to join the tourist promotion agency. The township would be listed in the Visitors Guide and on their website. No action was taken.

The minutes and treasurer's report from the Recreation Board was distributed to the supervisors.

The Southwestern Pennsylvania Commission will be conducting a Road Safety Audit on State Route 51 from the intersection of State Route 168 to the Cannelton Road intersection on November 16th. Bob Long and Dan Rastatter plan to attend. Dan McLean and a member of the Fire Department will also attend.

The supervisors approved hiring an electrician to check the electrical system at Fire Station No. 1. The motor on the furnace blower at the back of the building which heats the truck bays, bathrooms, and office room burnt up because of low voltage. The old electrical box there may have to be replaced.

Matt Balik and Bob Long attended a meeting on Emergency Management. Matt stated under Title 35 the duties of the Board of Supervisors is to review the Emergency Operations Plan every two years and update the Notification and Resource Manual (NARM) every year.

An executive session was held on legal matters.

The 2011 proposed budget was discussed and reviewed by the supervisors. Preliminary approval was given with no increase in taxes. The millage rate would stay at 12.5 mills, \$5.00 Per Capita Tax, .5 Wage Taxes, .5 Real Estate Transfer Taxes, Street Lighting .30 per frontage foot, and Water District .05% of Assessed Value. The budget will be adopted at the December 14th meeting. A notice will be published in the Beaver County Times.

Bob Long made a motion to adjourn the meeting. Dan Rastatter seconded the motion. Motion carried. Matt Balik adjourned the meeting at 10:20 P.M.
