

**Minutes of South Beaver Township Regular Meeting**

**November 12, 2025**

The regular November meeting of the South Beaver Township Board of Supervisors held in the South Beaver Municipal Building located at 805 Blackhawk Road was called to order at 7:00 P.M. by Jack Mintier. The Pledge of Allegiance followed.

Tom Miller made a motion to approve the October meeting minutes. Jack Mintier seconded the motion. Motion carried.

Tom Miller made a motion to approve the Treasurer's Report and pay the following bills: General Fund, Check No. #1918-#16958, Total \$49,429.19, Payroll Fund, Check No. #12651-#12696 Total \$47,582.68, State Fund, Check No. #2199-2200, Total \$2,935.69, Fire Tax, Check No. #219, Total \$319.69. Jack Mintier seconded the motion. Motion carried.

John Heyl gave the Engineer's report. It will be filed. John reported that the preconstruction meeting for the park trail project took place last week and the construction will be starting soon.

Dan Petrich gave the Police report. It will be filed. Chief Petrich received a resignation letter from full time patrolman Nicholas McHenry which will be added to new business.

Josh Krut gave the road report. The road department started working on the addition to the salt shed, met with the conservation district to move forward with the grant money for Sportsman's road, and the park water has been shut off.

There was no fire report.

Levi Stahl did a more research on the traffic signal at 168 & 51. His right to know request to the state was all information he already had or was denied, and he thinks he needs to clarify what he is asking for. He is looking for basic volume data at the intersection and received the 2025 crash data from South Beaver Police.

Jake Rosenberger said that there is information out there that Josh Kail's office reached out to hold a town hall and it was denied to use the Township building and asked the board if they could comment. Tom and Jack were interested in what the content of the meeting was, last communication was the inadequate space of the room. Jake asked if it was just South Beaver if it could be held at the Township building, the Supervisors weren't opposed.

Tom Miller made a motion to add the resignation letter from Nicholas McHenry to new business. Jack Mintier seconded the motion. Motion carried.

Tom Miller made a motion to accept Full Time Patrolman Nicholas McHenry's resignation. Jack Mintier seconded the motion. Motion carried.

Tom Miller made a motion to approve the Conforti Subdivision contingent upon the planning module being approved by the DEP. Jack Mintier seconded the motion. Motion carried.

Tom Miller made a motion to approve the preliminary budget for 2026. A notice will be advertised in the

paper and the final budget will be adopted at the regular supervisors meeting on December 10, 2025. Jack Mintier seconded the motion.

Motion carried.
