Tom Miller made a motion to hire Cody Searfoss as part time patrolman with a retroactive hire date of October 2, 2025. Jack Mintier seconded the motion. Motion carried. The police department is still actively looking for a full-time officer in addition to the hiring of part time patrolman Searfoss.

Tom Miller made a motion approve the exoneration of Township taxes on two dilapidated mobiles homes in Elmbrook Country Court. Jack Mintier seconded the motion. Motion carried.

Tom Miller made a motion to accept the renewal quote for health insurance through Highmark. Jack

Mintier seconded the motion. Motion carried.
